

Advice When Buying a New Car

Making the decision to buy a new or used vehicle can be an exciting but also daunting task. Capitol Credit Union is here to help you through the process to get you behind the wheel of a new ride. Here are some helpful tips from CCU to assist you in your next car-buying process.

1. Do your research

The most important thing you can do before visiting the dealer is to research the vehicle you wish to buy and how much you can afford to spend. Keep in mind that the price the dealer advertised does not include Tax, Title, and license, or any ancillary products you may wish to purchase. To get the best price, shop around and compare similar units from multiple dealerships.

2. Get Pre-approved at Capitol Credit Union

Before going to the dealership, get pre-approved by calling a Capitol Credit Union Loan officer (512-827-2526) or applying online at www.ccutx.org. This will put you in the best possible position to be able to negotiate the best price for the vehicle you want. CCU offers all the products that the dealers sell such as Guaranteed Asset Protection (GAP) and Mechanical Breakdown Coverage (MBI) at a fraction of the cost that dealers will charge.

3. Close the Deal

Once you have found your new car and negotiated the price, the dealer will send the purchase order to a CCU Loan Officer for a quick, convenient, and paperless loan closing.
